*Please note that the processing time (# of business days) is a good faith estimate and may change depending on the volume of work received at our offices and the resources available at the Secretary of State's offices. The number of business days does not take into consideration the FedEx/UPS shipping to and from the State and the FedEx/UPS shipping back to your return address. We recommend that you do not book any appointments or make any reservations until your documents are complete and delivered back to your return address. Orders over \$500 will require a signature upon delivery. Please expect delays during the last three weeks of December and the first week of January (Holiday Season). FedEx/UPS interoffice shipping fee is \$35. FedEx/UPS international priority shipping fee is \$100. Please review the Terms and Conditions on our website. **County authentication processing time is estimated and in addition to the processing time of the State.

Note: Documents improperly notarized and returned by the State are immediately assessed a \$125 non-refundable fee. If your documents require notarization, please be sure to find an experienced notary public with a minimum of 5 years of service. In addition to the notary's stamp and signature, the notary must also include proper notarial wording. If the notary makes a mistake, your documents will be rejected and you will have to start over costing you time and money.
