We recommend that you do not book any appointments or make any reservations until your documents are complete and delivered back to your return address. Orders over \$500 will require a signature upon delivery. Please expect additional delays during the summer season (June through September) and during the Holiday season (November through January). FedEx/UPS interoffice shipping fee is \$35. FedEx/UPS international priority shipping fee is \$100 to most countries. Please review and accept the Terms and Conditions listed on our website. \*\*The County Clerk authentication processing time is estimated and in addition to the processing time of the State. Some types of documents will require County Clerk authentication before the state will attach the apostille. Please contact us before you mail in your documents for processing.

**Notarized Documents:** Documents improperly notarized and returned by the State are immediately assessed a \$125 non-refundable fee. If your documents require notarization, please be sure to find an experienced notary public with a minimum of 5 years of service. In addition to the notary's stamp and signature, the notary must also include proper notarial wording. The notary can reference their notary handbook provided by the state. If the notary makes a mistake, your documents will be rejected, and you will have to start over costing you time and money.

Our volume discount fee for each apostille applies to 10+ documents mailed in at the same time and originating from the same state. Certain restrictions apply. Please contact us for details.
